Puroptics Hypromellose 0.3% Eve Drops also ensures relief from ophthalmic stress due to the use of contact lenses.

Puroptics Hypromellose 0.3% Eye Drops is compatible with contact lenses.

Puroptics Hypromellose 0.3% Eye Drops can be used in case of a moderate dry eye syndrome or dry eyes symptoms or more commonly, in case of discomfort sensation.

INSTRUCTION FOR USE

- · tear off the tamper-evident seal before the first administration;
- · remove the protective cap and open the bottle;
- instill 1/2 drops in each eye slightly pressing the bottle;
- the gradual emptying of the bottle may be associated with the need to exert a higher pressure to allow the delivery of the product. This is due to the proprieties of the closure system act to preserve the sterility and the chemical and physical characteristics of preservative free solutions;
- after use, shake the bottle once downwards in order to remove any excess before replacing the cap on the container and close the bottle:
- it is suitable for frequent use, even several times a day (3 or 4 time or more often if required) or according the doctor indication.
